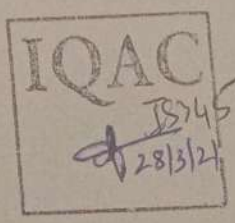

4. Activity points earning for students who should undergo AICTE ACTIVITY POINTS .

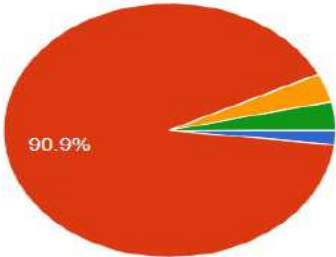

To whom do Human Rights apply?

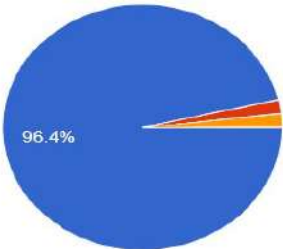

Where is the headquarters of National Human Rights Commission

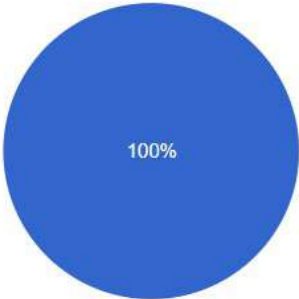
